### **USCIS Atlanta Liaison Meeting**

The USCIS Atlanta Liaison Committee met this morning with leadership with the Atlanta Field Office. They'll have the official Q & A for us later, but some items of note...

- Attached is the InfoPass policy. USCIS stated that in order to obtain an I-551 stamp, emergency advance parole, or other service to please do the following:
  - o Try to schedule an InfoPass appointment first
  - If InfoPass is unavailable, emergencies will be decided on a case-by-case basis. Emergency walk-in appointments will only be taken until 12:30 on Monday, Tuesday, Thursday and Friday and until Noon on Wednesday
  - The emergency must be documented. A letter from an employer denoting possible termination, a rejection from DDS, a signed letter from a physician are all good examples.
  - If your client is told no, but has documentation, they should ask for a supervisor or the duty officer.

- USCIS Atlanta has revamped the cover sheet used by ICE when A files are transferred from Court to USCIS. With this new cover sheet, we should see fewer cases being misrouted to archives when they should be set for an interview.
- ISO Y. Garcia passed away last weekend. He used to be an InfoPass officer, but had been conducting interviews for the past year. No details were given, but his service will be on Monday in Puerto Rico. Please keep his family and friends in your thoughts.

### **Board of Governors Meeting Summary**

The mid-winter BOG meeting was held last weekend in Cancun. Some highlights from the meeting include:

- AILA has adopted a position on restructuring the Immigration Court system. Please see page 32 of the <u>BOG Materials</u> for details. There are still issues to work through (such as retention of current judges), but this provides AILA with a starting point in the conversation.
- AILA is developing a database of talent. This includes evaluations from speaking engagements, volunteer positions, etc. If you'd like to be included in the database, the best thing to do is to start volunteering (see above).
- AILA was referenced 2.5 times more in the media last year than before. AILA members are being recognized as the experts in the field (as they should!).
- Strategies to Fight include...
  - o Building up coalitions within the business and litigation arenas
  - Media campaigns, such as the "Invisible Wall" to show the impact of new policies and priorities on legal immigration
  - Revamping and rebuilding our national liaison relationships
  - Build a litigation task force
- We continue to look at ways for AILA National and local chapters to work together and to complement each other's work and to not have your inbox flooded with pro bono requests, media campaigns, etc.
