SB 452 Update

Earlier this week, a waterdowned SB 452 passed the Public Safety and Homeland Security Committee in the House. The bill is headed to the House Rules Committee and then the House floor and then back to the Senate in light of the changes to the text.

Although the bill is better, it still harms immigrant communities with constitutional violations, eroding trust, and it does not take into account the complexities or realities of immigration law.

Please continue calling Speaker David Ralston (404-656-5020) and Governor Deal (404-656-1776) to show your strong opposition to the bill! Together, we've slowed down and modified this bill, but there's still work to do.
