#### **Operation Mega Cancelled?**

Seems like ICE had second thoughts about doing their largest raid in history on the same weekend that Hurricane Irma hits the Southeast. ICE announced last night "There is currently no coordinated nationwide operation planned at this time. The priority in the affected areas should remain focused on lifesaving and life-sustaining activities." We don't know if that means the entire operation is cancelled or if only the impacted areas will be spared as part of this raid. As always, it's best to remind clients to be alert, to know their rights, and to have a plan in place in the event of apprehension.
