Potential Government Shutdown How Will It Impact Us?

Although we don't know what will happen with the Senate today, AILA's Government Relations team has already put together information that will help us navigate a potential shutdown. Please review the updated "What Happens if the Government Shuts Down" resource page. In addition, AILA's liaison committee chairs and vice chairs have also reached out to the various federal agencies to confirm that regular shut down protocols, as described in the resource page, remain in place, or if not, what changes are anticipated. Thus far, all agencies who have responded have confirmed that shutdown protocols remain status quo. Update on Dream Negotiations from AILA Executive Director, Ben Johnson

Momentum continues to build to reach a solution for Dreamers. In the Senate, the Graham/Durbin proposal (bill text still not released) now has a total of 7 Republicans and 3 Democrats sponsoring it. In the House, the Hurd/Aguilar bill has about 50 total sponsors evenly split between Rs and Ds. More rank and file Republicans are now calling for a solution for Dreamers. That level of support is putting more pressure on Speaker Ryan and Leader McConnell to do something on immigration. At this point, AILA continues to urge

both Rs and Ds to push their leaders to fight for a solution on Dreamers and TPS to be added into the spending deal. This is the only way that immigration can be done in this Congress—any promises made to bring an immigration bill for a vote as a stand-alone (such as what McConnell pledged) are empty promises. We will continue to update you and put information on the webpage as it unfolds.
