#### FAIR Miscalculates the Cost of Unauthorized Immigration In A New Study

Here's why reports of undocumented immigrants costing taxpayers billions of dollars are flat-out wrong.

#### The House Approves \$10 Billion for Trump's Border Wall

The timing of the Committee's vote is significant—it likely represents Republicans' willingness to use border wall funding as a bargaining chip for both the year-end government funding debate and negotiations over the fate of the Deferred Action for Childhood Arrivals (DACA) initiative.

#### The Senate Has Confirmed Lee Francis Cissna as Director of USCIS

Cissna will oversee the agency in charge of adjudicating and issuing most immigration-related requests into the United States—including the Trump administration's termination of Deferred Action for Childhood Arrivals.

#### As the DACA Renewal Deadline Approaches, 50,000 Dreamers May Face Deportation

The Department of Homeland Security has estimated that nearly 50,000 Dreamers have so far not submitted the necessary paperwork and fee, and would therefore be at risk for deportation when their DACA expires over the next five months.

#### Supreme Court Likely to Decide Constitutionality of Immigration Detention Without Bond

Justices will tackle whether the Constitution allows the government to detain noncitizens for more than six months without ever giving them an opportunity for a bond hearing.

#### The White House Has Slashed Refugee Admissions to Record Lows

The United States will only admit a maximum number of 45,000 refugees. This represents the lowest refugee admissions ceiling ever set by the U.S. government
