Back in 2010, a young woman was just trying to go to college when campus police pulled her over for allegedly blocking traffic while waiting for a parking space. Apply a little imagination and one extremely vindictive Cobb County Sheriff, and you end up with the national news saga of Jessica Colotl, which ended with Jessica receiving deferred action before DACA even existed. Once DACA did exist she received DACA twice until this year when DHS decided her grant of DACA was no longer consistent with the government's enforcement priorities.

Our colleagues Chuck Kuck and Danielle Claffey, along with the ACLU, filed suit, and then filed for a temporary restraining order.

#### **Atlanta EOIR Updates**

Our EOIR Committee has been in touch with the Atlanta Immigration Court's Administrator and has a bit of news to report...

- Mailing address for the Annex. If you print your labels from USPS, you have noticed that the official address is not recognized. If you want to use the USPS, you'll need to switch the "NW" to "NE" on the street address.
   If you have had a mailing returned to you, they want to see it. Please contact our EOIR liaison chair, Jennifer Bensman, at jen@jenniferbensmanlaw.com with a copy of the returned envelope.
- 2. IJ Criss' Docket The overall issue is that on Tuesday and Thursday there are 8:30 and 9:30 non-detained master calendars and a detained docket at 10:00. 8:30 are initial MCs and 9:30 are resets. If IJ Criss is done with one docket early, he'll move on to the next.
  - By December, Judge Criss should not have a mixed detained/non detained docket in one morning.
  - Through the end of the year, if you have a master calendar hearing before IJ Criss, AILA recommends that you disregard the printed time and appear at 8am.

#### Department of Justice Threatening Immigration Judge Independence

Last week, the Washington Post broke the <u>story on the DOJ's plan</u> to impose numeric quotas on immigration judges as part of their performance evaluations. See link below. The judges' union and DOJ are still in negotiations, and the judges are now speaking out against this as fundamentally undermining their independence and the integrity of the courts, not to mention the Constitution's guarantee of due process.

AILA has been aware of this development for several weeks and has been working with our EOIR National Committee and ExCom to develop a response strategy. We have released a press statement, an explanatory video – featuring EOIR committee chair Kelli Stump, and a policy brief, and we are already working with Congress and other partners to pushback against this DOJ plan.
