Committee Highlight: CBP

Why wait a month to share the mission of our Customs and Border Protection Committee?!

The CBP committee is excited to support the Chapter through events like the annual Hartsfield-Jackson tour and increased outreach! Our committee exists to: (1) communicate the concerns of chapter members to the local CBP field office; (2) disseminate useful information and best practices regarding local CBP practices to the chapter; and (3) advocate on behalf of local chapter members before the local CBP field office regarding local CBP practices and policies.

In that regard, CBP Atlanta has communicated two policy reminders that AILA members may find useful. First, nonimmigrants, such as H-1B, arriving with a passport that expires prior to the petition validity dates can only be admitted to the expiration date of the passport presented. CBP cannot update or extend the I-94 record after the fact if the nonimmigrant later renews his or her passport.

Second, CBP's online travel history feature is only a tool to assist the public and not an official record, and may not be complete. The provided travel history may not reflect: land border arrivals/departures, closed loop cruise arrivals/departures, air carrier reservation updates, and USCIS updates, changes of status, extensions of stay, or adjustments of status. U.S. Citizen and Lawful Permanent Resident travel is NOT provided on this website. If the travel history is not complete, there is no action for the nonimmigrant or for CBP to take.
