# 70 Georgia and National Organizations Ask the Georgia Congressional Delegation to Investigate Conditions at Georgia Immigration Detention Centers

AILA National was happy to add their support to a <u>letter</u> to the Georgia Congressional delegation requesting an investigation of the conditions at Georgia immigration detention centers, specifically the Stewart Detention Center and the Irwin County Detention Center, following the death of Jean Carlos Jimenez-Joseph at Stewart.

The organizations are asking the Georgia Congressional delegation for a prompt investigation of these facilities to address human rights violations and prevent future tragedies.
