Other Immigration News and Events

Pro Bono Assistance Needed for Iraqis Detained in Etowah

You may be aware that several hundred Iraqi nationals subject to prior orders of removal were arrested and detained by ICE this past summer. This came about after Iraq agreed for the first time in decades to accept repatriation of many of its nationals, in exchange for being left out of the second Executive Order/Travel Ban.

The district court's stay on removals is for 90 days from the date that the government produced the A files and ROPs to the detainees. That date was 11/27 for most of the class. That means that the motion to reopen has to be filed by 2/25/18 or thereabouts. The 90-day clock is ticking, and that makes finding counsel urgent—particularly in light of the upcoming holiday break. The good news is that all but one of the Etowah detainees signed designations that permit the Hamama team to get copies of their files, so attorneys who take those cases can hit the ground running. Preparing a motion to reopen before the stay expires is definitely do-able, but the sooner we find counsel the better.

Pro Bono Assistance Needed for Detained Vietnamese

A large number of Vietnamese people with final orders of removal who were recently re-detained pending an apparent change in Vietnam's repatriation policy. An ad hoc group of lawyers and advocates have completed a number of screenings, and now we are working to try to place cases with pro bono lawyers who can handle motions to reopen. Currently, the vast majority of these individuals don't have attorneys. Initially, most folks were detained at Stewart, but some have gotten moved to Folkston, Texas, or back to California.
