### Chapter News

### National Day of Action Update





A huge thank you to Georgia NDA Coordinator, Kamala Sessoms and our Alabama NDA Coordinator, John Charles Bell, for organizing an amazing slate of meetings last week in DC! We talked about the need for oversight, the slashing of legal immigration, and what it would take to get DACA passed (among other things). Immigration isn't the easiest sell right now, but the Congressional staffers we spoke to were reasonable, accommodating and they listened.

#### **AILA Board of Governors Report**

As your Chapter Chair, I represent you before our national Board of Governors (BOG). YOu can always review BOG materials on <u>AILA.org.</u> We discussed the following:

- The need to partner with health care providers in regards to the proposed public charge policy changes (which, among other things, punishes immigrants whose US citizen children receive the benefits they are entitled to)
- The need to sue USCIS more. We had a great presentation from a former OIL and AAO attorney to talk about the agency's weaknesses. AILA National will be helping us to coordinate a planned litigation attack and providing members with the necessary resources to move forward.
- Despite moving the Annual Conference from Texas to California, AILA had a net gain in 2018.
- The Civility Policy went through revisions and passed.

Your petition must be in writing, endorsed by five other chapter members in good standing, and submitted to me our Secretary, Elizabeth Matherne, no later than Wednesday, May 2, 2018. On or before Saturday, May 12, 2018, our Secretary will publish the final slate of nominees. Any member in good standing may cast a secret ballot after that date for any nominee who is opposed to an office. Voting by secret ballot will commence from May 12 until the close of the Annual Meeting on June 1, 2018.

You may cast your ballot at the Annual Meeting, but for those who are unable to attend, we will set up some sort of mechanism to allow you to vote prior to the meeting. Instructions for accessing that mechanism will be provided after the time for nominations closes on May 12. The results of the election will be announced after the close of the Annual Meeting.

We are awaiting confirmation from USCIS leadership, but for those of you who may not have seen this, Member Ken Levin reported the following on our Yahoo listsery:

I was at CIS this morning with a client to obtain an I-551 stamp. It took my paralegal only about a week to reserve the appointment. When we got up to the counter I was advised by the Infopass Officer that CIS Atlanta has instituted a policy change regarding I-551 stamps.

The current policy is as follows:

- Infopass appointments are no longer required to obtain an I-551 stamp. A ticket will be provided as a drop in appointment.
- A drop in appointment must take place in a 30 day window prior to expiration of the Applicant's current green card or I-551 stamp.
- I-551 drop in appointments are accommodated from 7am -noon M-F.

Also, I wanted to bring to everyone's attention that CIS Atlanta now takes the position that an Applicant will no longer be entitled to unlimited I-551 renewal stamps where the Natz application is filed 180 days prior to expiration of the green card. The current policy is that CIS Atlanta will give one "courtesy" 6 month stamp. If the Applicant is not naturalized in that six month window, then CIS Atlanta is requiring the filing of an I-90 to receive any subsequent I-551 stamps.

While in DC, I also learned that InfoPass is being completely overhauled. USCIS states that they need those resources to go towards adjudications and not to simply telling people that their cases are pending. Soon, InfoPass appointments will only be scheduled by the NCSC and will be for documentary purposes only (I-551 stamps, granting of AOS by an IJ, etc.). AILA and our liaisons will stay on top of this development.

### **DOJ Halts the Legal Orientation Program**

Since the news broke last Monday evening (4/2), AILA's Communications and Government Relations teams have been working with reporters to cover this issue. On Wednesday (4/4), AILA organized a <u>telephonic press conference</u>. AILA also participated in a <u>hill briefing</u> this week (along with NAIJ's President) in order to educate the Senate staff about the current state of our immigration courts. There has been a lot of interest from both media and the hill, partly due to last Sunday's HBO show, "Last Week Tonight with John Oliver" which was <u>very powerful segment</u> on the injustices in our immigration courts.
