### Ethan Pham Running for U.S. Congress, District 7

From the Ethan Pham for Congress campaign...

Ethan Pham was born in South Vietnam. His father fought for the South Vietnamese military against communism, standing alongside American forces. After the communists took over, Ethan's father was imprisoned in a "re-education camp" for several years, where he was worked and tortured. On his release, the family applied to come to the United States.

Ethan arrived with his family when he was 11 and worked his way through college and John Marshall Law School to become a city attorney advising local governments. While doing so he met an equally talented lawyer named Jenny, and the pair married last year. Together they own a law practice on Jimmy Carter Boulevard that now employs a talented and diverse staff of six.

Now that Ethan has achieved his own version of the American Dream, he's returning the favor. In 2017 he teamed up with Gwinnett County Solicitor Rosanna Szabo and other community leaders to form a task force combating scammers who take advantage of new immigrants. Ethan and Jenny also co-founded a non-profit organization, the Vietnamese American Bar Association of Georgia, that helps educate Vietnamese immigrants on American law.

We need more people like Ethan Pham running for office, to change the tone of our fractured political climate and focus on the values we all share: healthcare as a right for every American, fair and compassionate immigration policies, and leadership in our nation's capital.

Despite being out spent 2-1 Ethan is tied for first place in a recent poll in District 7. Donating now could help him reach out to undecided voters and secure a victory for them on May 22nd. You can <u>contribute online here</u>.

## **National News**

#### The End of Administrative Closure

On May 17, 2018 the Attorney General issued a ruling in *Matter of Castro-Tum*, 27 I&N Dec. 271 (A.G. 2018). <a href="https://www.justice.gov/eoir/page/file/1064086/download">https://www.justice.gov/eoir/page/file/1064086/download</a> AILA's press release says it best:

Today, in a precedent decision, the Attorney General of the United States announced that immigration judges and members of the Board of Immigration Appeals no longer have the authority to "administratively close" court cases before them, with the exception of cases that meet very narrow criteria. With this move, the Attorney General has eliminated a critical docket management tool, effectively ensuring that the immigration court system will remain encumbered with massive case backlogs well into the future.

AILA President Annaluisa Padilla responded, "In today's decision the Attorney General grossly misinterprets the law and disregards existing federal regulation and decades of immigration court practice. The Attorney General cherry-picked a case that is not reflective of the universe of cases that have been administratively closed and with the stroke of a pen, dismissed the inherent authority of judges to manage immigration court proceedings, an authority that has been recognized for more than 30 years and that the National Association of Immigration Judges strongly supports as a matter of court efficiency. Unfortunately, today's decision represents the first in a series of efforts by the Attorney General to single-handedly rewrite immigration law."

AILA Executive Director Benjamin Johnson stated, "This decision is yet another effort by this administration to undermine due process in immigration proceedings. Due process demands that we maintain an immigration court system with independent judges who have the authority and flexibility to make decisions that are not only legally correct but are also grounded in fundamental fairness. Immigration judges use administrative closure for many legitimate reasons, including court efficiency. But it is also often employed when an immigrant is eligible for some type of legal status that can be pursued outside of court with U.S. Citizenship and Immigration Services (USCIS). Forcing these cases through the court system while another agency is determining the person's eligibility for an immigration benefit wastes finite court resources that can and should be used on more pressing cases. Today's decision erodes judicial independence and strips due process from immigrants, turning the court into a machine for deportations rather than an arbiter of justice."

A few BOG candidates have asked us to share their bios with the chapter. In no particular order - here we are:

Mike Jarecki: See attached flyer.

**Kevin Miner:** I am writing to ask for your vote. AILA needs Board members with experience in policy development and advocacy, and that is what I bring to AILA.

I have been active with AILA for more than 15 years, and was honored to serve as Chair of the Department of Labor Liaison Committee from 2015 to 2017. As DOL Chair, I worked to foster an atmosphere of trust and open communication, combining zealous advocacy for AILA members with collegiality and professionalism. During this time I have been involved in numerous comments, amicus briefs, and other advocacy activities. I was particularly proud to have been part of the team that convinced DOL to withdraw the ill-conceived "H-14 FAQ" that would have wreaked havoc on thousands of pending PERM applications. I am also a co-author of Business Immigration: Law & Practice, Second Edition, which

provides a detailed explanation of the law combined with practical advice on preparing and filing strong and effective petitions.

These are challenging times. Legal immigration is under attack. We need to be focused on practical and realistic solutions. We need to spend as much time -- and likely more -- stopping bad changes from happening than we spend advocating for positive reform. During my past three years on the Board, I was actively involved in the Board's H-1B task force helping to identify the kinds of restrictions that might be acceptable in the H-1B program, and what kinds of changes we would need to actively fight against. I have done this kind of work on behalf of clients for more than a decade, and AILA needs leaders with this kind of expertise.

**Ellen Freeman:** Over the past 17 years, I have proudly served AILA at local, national and international levels. - Engaging in strong public and media relations to emphasize our attorneys' pro bono contribution, dedication to our clients beyond the practice of law, and willingness to forgo profit and fight for basic human rights and dignity.
