#### FROM OPLA ATLANTA CHIEF COUNSEL, RYAN MATSUNO

Question presented by liaison: What form or method of PD is being exercised now given the ongoing federal litigation/injunctions/stay of injunctions? PD is still a legitimate function of a prosecuting body/agency such as OPLA, correct?

We are still stuck with 5th circuit injunction, even though 6th circuit dismissed from their district court, because OPLA does not interpret the 6th circuit case binding outside of the 6th circuit. (5th circuit has parallel case in Louisiana where 5th circuit has declined to take up the issue since the 6th circuit dismissal).

Interpretation of 5th circuit injunction: OPLA can't exercise PD under (Mayorkas/Doyle) priority scheme. However, OPLA always has the inherent discretion to exercise PD. Extremely case by case and up to the ACCs. Will be different per each ACC and that's okay.

Two factors the ACCs are looking at (if that ACC decides they want to pursue without management direction):

- 1. When is it advantageous to the agency for efficiency of the docket. This most often means there is some other relief that CIS can grant relief and therefore the case does not need to take space on EOIR docket. This is not appropriate in all cases.
- 2. If otherwise therwise required in the interest of justice. For example, evidence of hardship to family to make evaluation under this rubric; doesn't need to be hardship to QR unless you're asking for stipulation

AreStipulations still ok/happening? YES

Escalations: anytime members receive declination (to request for dismissal or stipulation), email CC <Ryan.H.Matsuno@ice.dhs.gov> directly to do independent review of ACC's declination.
