- Thank you to Danielle Claffey for agreeing to let me steal her amazing story of a hard-fought triumph for this month's Story—read her account below:
  - Great outcome on a federal litigation case...

My client is an Indian national and the principal beneficiary of an EB AOS that was denied in 2018. After several MTRs by prior attorneys, he came to us to litigate. I first filed a mandamus on the 290b, and the AOS denial was affirmed. So, I basically begged general counsel of his former employer (large state

agency) to provide us with an official letter clearing our client of prior alleged fraud that was the basis of the denial. Mind you, the denial also led to the AOS denials for his wife and two adult children. None of them had any options to stay in the US, but for getting the AOS' reopened. We refiled a new complaint challenging the actual fraud claim, and USCIS reopened without filing a motion to dismiss in court despite the Supreme Court decision in Patel v. U.S. Attorney General. They just approved the principal's AOS... [The family's green cards arrived just after the New Year!!!]

When you know USCIS issued an unjust decision, don't give up until you get the outcome that is deserved... federal court is still an excellent tool to hold USCIS accountable!
