
**The Kilmar Abrego Garcia case and its lessons for immigration practice today.**

Keynote speaker Simon Sandoval-Moshenberg (Murray Osorio PLLC, Fairfax, Va.) represents Kilmar Abrego Garcia in his lawsuit against the government for wrongful removal to El Salvador despite a withholding-of-removal order. What first seemed like a one-off mistake that would be quickly corrected quickly spiraled into a battle royale that made its way to the Supreme Court and continues to this day, and has been described as emblematic of many of the legal issues facing the immigrant community in the current era.
